Wilcox St. Castle Rock, CO 80104

Ordinance No. 2018-027

An Ordinance Directing that the November 2018 Regular Municipal Election of the Town of Castle Rock be Conducted by Douglas County as a Coordinated Election on November 6, 2018

Subject Matter Summary:

The proposed ordinance directs that the November 2018 municipal election be conducted by Douglas County as a coordinated election on November 16, 2018.

ORDINANCE NO. 2018-027

AN ORDINANCE DIRECTING THAT THE NOVEMBER 2018 REGULAR MUNICIPAL ELECTION OF THE TOWN OF CASTLE ROCK BE CONDUCTED BY DOUGLAS COUNTY AS A COORDINATED ELECTION ON NOVEMBER 6, 2018

WHEREAS, pursuant to Section 4-2 of the Town of Castle Rock Home Rule Charter (“Charter”), regular municipal elections are to be held each even-numbered year on the first Tuesday following the first Monday of November, and

WHEREAS, by Ordinance No. 2018-026, the Town Council has referred certain proposed amendments to the Charter to the electorate at the regular municipal election, and

WHEREAS, Section 2.01.300 of the Castle Rock Municipal Code prescribes that the Town Council may determine any regular election shall be conducted through Douglas County as a coordinated election, and

WHEREAS, it is necessary and advisable for the regular municipal to be conducted by Douglas County on behalf of the Town under the Uniform Election Code of 1992, and pursuant to Intergovernmental Agreement with Douglas County as authorized under Section 2.01.300 of the Castle Rock Municipal Code.

NOW, THEREFORE, IT IS ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF CASTLE ROCK, COLORADO:

Section 1. Conduct of the Regular Election. The November 2018 regular municipal election shall be governed by and conducted in conformance with the Uniform Election Code of 1992, as a coordinated election, and pursuant to an intergovernmental agreement between the Town and Douglas County (“IGA”). Town officials are authorized to execute the IGA in the form required by the Douglas County Clerk and Recorder.

Section 2. Actions by Officials. Officers and employees of the Town and election officials are authorized to take all actions necessary to effectuate the provisions of this Ordinance and conduct the regular municipal election on November 6, 2018 in accordance with the Uniform Election Code of 1992 and the IGA.

Section 3. Effective Date. This Ordinance shall take effect upon its adoption on second and final reading pursuant to 2.01.300.C of the Castle Rock Municipal Code.

Section 4. Severability. If any clause, sentence, paragraph, or part of this ordinance or the application thereof to any person or circumstances shall for any reason be adjudged by a court of competent jurisdiction invalid, such judgment shall not affect the remaining provisions of this ordinance.

Section 5. Safety Clause. The Town Council finds and declares that this ordinance is

promulgated and adopted for the public health, safety and welfare and this ordinance bears a rational relation to the legislative object sought to be obtained.

APPROVED ON FIRST READING this 17th day of July, 2018 by a vote of 5 for and 0 against, after publication in compliance with Section 2.02.100.C of the Castle Rock Municipal Code; and




