

**RESOLUTION NO. 2018-011**  
**RESOLUTION APPROVING A VARIANCE PURSUANT TO**  
**CHAPTER 9.16.070.E OF THE CASTLE ROCK MUNICIPAL CODE**  
**FOR NIGHT TIME CONSTRUCTION ACTIVITIES RELATED TO THE 2018 PAVEMENT**  
**MAINTENANCE PROGRAM, 2018 BRIDGE MAINTENANCE PROGRAM, 2018 TOWN**  
**FACILITY PARKING LOT IMPROVEMENT PROJECT, AND 2018 CAPITAL IMPROVEMENT**  
**PROGRAM PROJECTS**

**WHEREAS**, the Town's Public Works Department has made application for a variance to the Town's noise ordinance pursuant to Chapter 9.16.070.E of the Castle Rock Municipal Code, necessary for 2018 Pavement Maintenance Program, 2018 Bridge Maintenance Program, 2018 Town Facility Parking Lot Improvement Project, and 2018 Capital Improvement Program Projects; and

**WHEREAS**, to minimize inconvenience to the public, the Public Works Department anticipates that night maintenance is necessary, and

**WHEREAS**, the Town Council finds that the activity will be of temporary duration and even with the application of the best available control technology, the maintenance cannot be done in a manner that would comply with Chapter 9.16.

**NOW, THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF CASTLE ROCK AS FOLLOWS:**

**Section 1. Approval.** The application for a variance from the Town's Public Works Department beginning April 2, 2018 is hereby approved subject to the following restrictions:


1. The variance shall be in effect between April 2, 2018 and December 31, 2018. This time period may be extended by up to one month at the discretion of the Public Works Director.
2. The variance shall apply only to maintenance work performed for pavement marking, pavement maintenance, pavement repairs, roadway construction, street sweeping, and asphalt mill and overlay. Any other work shall comply with the noise restrictions set forth in Chapter 9.16 of the Castle Rock Municipal Code.

**PASSED, APPROVED AND ADOPTED** this 20<sup>th</sup> day of February, 2018 by the Town Council of the Town of Castle Rock, Colorado, on first and final reading, by a vote of 5 for and 0 against.




