An Ordinance Amending Section 15.42.010 of the Castle Rock Municipal Code Adopting by Reference as a Primary Code The 2018 Transportation Design Criteria Manual

Subject Matter Summary:

The purpose of this ordinance is to adopt updates to codes and standards for regulating construction related to transportation infrastructure to promote compliance with industry standards.

Said ordinance adopts by reference, as primary code of the Town of Castle Rock, the following Criteria Manual (as defined in 31-16-201, C.R.S.)

ORDINANCE NO. 2018-043

AN ORDINANCE AMENDING SECTION 15.42.010 OF THE CASTLE ROCK MUNICIPAL CODE ADOPTING BY REFERENCE AS A PRIMARY CODE THE 2018 TRANSPORTATION DESIGN CRITERIA MANUAL

WHEREAS, the Town of Castle Rock is a home rule municipal corporation and the Town Council is empowered to adopt such ordinances as are necessary and convenient to protect the health, safety and welfare of the community; and

WHEREAS, the Town Council has determined the necessity of adopting regulations and standards to govern in a safe, fair and equitable manner the construction of transportation facilities in the Town; and

WHEREAS, the codes and standards are established and periodically updated to serve as the most practical basis for regulating construction; and

WHEREAS, the Castle Rock Municipal Code imposes a comprehensive regulatory framework that governs the submission, processing, review and consideration of land use applications and permits and prescribes criteria and standards for construction documents and permits; and

WHEREAS, public hearings have been held before the Town Council and the Ordinance has been properly noticed in accordance with the Town regulations and §31-16-203, C.R.S.

NOW, THEREFORE, IT IS ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF CASTLE ROCK, COLORADO:

Section 1. Amendment. Section 15.42.010 of the Castle Rock Municipal Code is amended in its entirety to read as follows:

15.424.010 Adoption

The Town adopts by reference the following code: the *Transportation Design Criteria Manual*, published December 4, 2018 by the Town of Castle Rock, 100 N. Wilcox Street, Castle Rock, Colorado, and all secondary codes referenced therein. Three copies of the Transportation Design Criteria Manual shall be maintained in the office of the Town Clerk and may be inspected during regular business hours, the same being adopted as if set out at length herein.

Section 2. Severability. If any clause, sentence, paragraph, or part of this ordinance or the application thereof to any person or circumstances shall for any reason be adjudged by a court of competent jurisdiction invalid, such judgment shall not affect the remaining provisions of this ordinance.

Section 3. Safety Clause. The Town Council finds and declares that this ordinance is promulgated and adopted for the public health, safety and welfare and this ordinance bears a rational relation to the legislative object sought to be obtained.




