HAUL ROUTE REQUIREMENTS:

- Applicant request must be made at least 7 days prior to the start of hauling operations.
 - Applicant is responsible for notifying any owner of privately owned streets of the hauling operations.
 - Haul route must remain on arterials and collectors with minimal residential impact.
 - Applicant is responsible for providing work zone safety that meets the standards set forth in the *Manual on Uniform Traffic Control Devices (MUTCD) if needed in conjunction with the haul route. Traffic control plans must be submitted 7 days prior to hauling operations.*
 - Applicant shall protect existing utilities, storm drains and structures from damage and shall be responsible for any repairs required as a result of the applicant's hauling activities, omissions or negligence, including any damaged to streets during hauling.
 - Applicant indemnifies and holds harmless the Town of Castle Rock and its officers, agents and employees from all liability, loss, cost and and/or damage to property.
 - Applicant shall provide daily street sweeping and street cleaning equipment and personnel necessary to keep streets clean during hauling operations.
 - Applicant shall comply with all requirements of the Grading, Erosion and Sediment Control (GESC) Manual.
 - Applicant's haul route is subject to reroutes or suspension due to conflicts with ongoing construction operations or failure to comply with haul route requirements as identified by the Town of Castle Rock.
 - Haul Operation Hours are Monday-Friday 7am to 6pm & Saturday (only by inspector permission) 8am to 5pm.
